


### 1. Are you a resident of New Gloucester?




### 2. What is your age?




## 3(a). How many regular or special New Gloucester Town Meetings have you attended in the last seven years?






5. Town Meeting should be continued (in some form).




# 6. There should be a minimum number of voters required to attend a regular or special Town Meeting in order to hold a Town Meeting.




#### 7. What should be the size of the Select Board/Town Council?




### 8. How should the Select Board/Town Council members be elected?




#### 9. There should be term limits for Select Board/Town Council members.



Residents have a voice and if they feel their elected officials are not hearing that voice, they have a recourse at the ballot box and/or through the petition process.

		Let me be clear from the start: if the charter that comes out of the commission process looks like our current town meeting system (with the final budget and ordinances voted on at the meeting), I will vote no and will do my best to get everyone I know in town to vote no.
		This is not to say that I don't think a town meeting can serve a purpose; I think it's a great way for the budget committee and selectboard to gather public feedback on a draft budget (to avoid another library fiasco), but NO BINDING VOTES should be held at that meeting. Instead, the final draft of the budget should be voted on through a ballot vote/referendum. That is the only way to ensure that every resident of voting age has equal access to the democratic process.
	In the past, I was unable to attend due to a scheduling conflict. Also,	The town meeting - as it is set up now - severely limits democratic participation in the budget approval and ordinance approval process (around 1% of the population attends - that's unacceptable!). It is an exclusive process that makes absolutely zero sense for a town of our size. My wife and I are both very motivated participants in the democratic process, but we would likely not be able to attend due to child care needs (at least, not both of us). I would also not attend an in person town meeting without a mask rule in place until COVID is far more under control. How many others are in the same boat? It's more that a fewI can tell you that.

	I attend most town meetings and special town meetings. However, I was not able to go to the special town meeting in June 2019 related to a property tax assistance for older residents due to a death in my family. Four of us in my family from New Gloucester were not able to attend that special town meeting which was held at night. The ordinance was voted down by a vote of 25 to 21. If we had been able to make that meeting, the ordinance vote would have at least been tied. To me, this shows the weakness in a town meeting vote on ordinances when only a small number of people turn out. This was a very important issue and one that affected many residents in town. I would prefer to see well-publicized public hearings on ordinances with a vote by the Selectboard and a safety-valve that would allow a petition for a full ballot vote if some percentage of the voters request it. Ordinances do not necessarily follow a predictable time line like the budget which is always voted on once a year at town meeting. With the growth in the town and the need to address issues in a timely manner, town ordinances need to be passed in a more timely and efficient way. While a special town meeting may provide opportunity to ask questions and debate an ordincance, it is not a democratic process for passing <sup>3</sup> / <sub>4</sub> "law" of the town. However, it's not always feasible to attend this, so it's beneficial if there is another way for the select board/town council to get input from the community. Ballotting is a great way to identify the majority of voters preferences, but it provides no input to the select board/town council if an item is voted down. Consider what happened with the library residents voted against the budget, but the select board provided no comprehensive means to obtain input about the reason(s) for this and subsequently put forth another budget that did not address the concern that residents had. Personally, I feel that ballotting (voting) is the best way to get town resident approval on select board recommendations, but there must be a forum for discussing these recommendations. Surveys such as this help town committees to get resident input on town issues. Open comment spaces such as this are an essential component of surveys in order to get more in depth feedback.

Those younger families represent the future of the town, and their absence from town meetings in recent years is undeniable. My spouse and I missed most town meetings when our kids were little and we both worked.
		Beyond that, having 100 or 150 residents - with no accountability - making budget and ordinance decisions for a 6000-person community is simply not representative. Send the budget to a referendum vote following public hearings and input from an *elected* budget committee that takes up both the capital and operating budgets or both elected budget and CIP committees. (Why are those two functions split? Why not a holistic picture?)
		I support a town council form of government, in particular so that ordinances can be enacted without waiting for an annual town meeting or calling a lightly attended special meeting. The town's uneven response to the pandemic was sobering - mostly seemingly off-the-cuff decisions by the then-town manager. Ordinance authority in a council (or emergency ordinance authority in the select board) would have provided clarity and formal opportunity for public input and quick action to respond to the emergency.
